Importance of Accurate Provider Network Data

Accurate information about your practice is critical to our members who rely on our directories. They need up-to-date information to make it easier to contact you. The Centers for Medicare & Medicaid Services (CMS) also requires us to have current information.

You can submit changes to your demographic data and location information online. We'll mail or email you a list of each individual and/or group practice. We'll include a web address or link that will take you to a portal where you can update your HMSA online directory (Find a Doctor) information. Currently, provider locations associated with medical groups can't be edited, but we're working to add online group updates. For now, providers should reach out to their group administrators to make any updates.

To update your information, your group administrator can fill out the applicable form from the list below and submit it to us:

COM Risk Adjustment Chart Review

In June, HMSA began the 2019 Medicare Advantage Risk Adjustment chart review project. If you haven't already, you may be contacted by a representative from HMSA or Change Healthcare to request medical records for your Medicare Advantage members. The request includes services performed between January 1, 2018, and June 30, 2019.

These medical records are used to validate information sent to the Centers for Medicare & Medicaid Services (CMS) to ensure CMS has accurate, complete, and valid data regarding our Medicare Advantage population. This data is essential to sustain the Medicare Advantage program.

Self-Service for Payment Determination Requests

To save your office time, we're aligning iExchange, a self-service tool, with the payment determination process. A payment determination is a provider request for HMSA to review a service that doesn't require precertification.

To protect patient confidentiality, you must have HHIN access to use iExchange.

Self-service for payment determinations will be rolled out in groups of providers starting October 1, 2019 based on volume. Group 1, durable medical equipment providers, must submit payment determination requests through iExchange starting on that date. Any faxes for payment determinations on or after that date will be returned to your office with a reminder to submit via iExchange.

Letters will be mailed in advance to impacted providers. If you don't receive a letter, this doesn't apply to you right now, so there's no need to call us. The date that surgeons, other specialists, and primary care providers will be required to use iExchange is still to be determined.

You can still use iExchange to submit requests for precertification and your office will benefit from reduced paper and faxes.



CODING & CLAIMS



Fundus Photography

Effective September 1, 2019, all commercial plans will see a decrease in the reimbursement of multiple CPT code 92250-Fundus Photography billed on the same day.

This change will align with Medicare's classification of the code as bilateral. The Relative Value Unit (RVU) amount for this procedure is based on the procedure being performed as a bilateral service.

Therefore, CPT code 92250 shouldn't be billed with site modifiers (RT, LT, 50) or with units greater than 1. The current fee is based on the Medicare fee with the intent to pay as bilateral and won't change.

Patient Driven Payment Model

In July 2018, the Centers for Medicare & Medicaid Services (CMS) finalized a new case-mix classification model, the Patient Driven Payment Model (PDPM). This model will be used under the Skilled Nursing Facility (SNF) Prospective Payment System for classifying SNF patients in a covered Part A stay. Learn more at cms.gov/Medicare/Medicare-Fee-for-Service-Payment/SNFPPS/PDPM.html.

Effective October 1, 2019, HMSA and CMS will implement PDPM for Medicare plans. No changes will be made to commercial and QUEST Integrations plans.



Incontinence Supplies

As of January 2019, HMSA QUEST Integration covers gloves and wipes under its Incontinence Supplies policy when criteria are met:

- Up to 100 gloves (not pairs) per month. Gloves are covered only for use by family caregivers or community care foster family home caregivers of adults and older children. Gloves are not covered for other care providers, including home health, home care, or hospice agency providers; they must supply their own.
- Up to 200 wipes per month. When billing for wipes, use CPT A4335 with modifier U2 and indicate the number of individual wipes (not boxes or packs).
